* For grower applications submitted between January 2009 and March 2010 a different method was used to determine the AEWR, based on the Bush Administration's H-2A regulations. This method, based partly on the Bureau of Labor Statistics Occupational Employment Survey – which does not survey farms – resulted in wage decreases of \$1 to \$2 per hour depending on the location. Secretary of Labor Hilda Solis revised the H-2A regulations and restored the former wage formula in 2010. Employers who obtained approval for H-2A workers by early March 2010 were permitted to pay the lower wage rates for the entire 2010 season.
