Maine	Required (limited)	<p>Instead of providing workers' compensation, the following employers of agricultural and aquacultural laborers may maintain an employer's liability insurance: (1) employers of seasonal or casual agricultural or aquacultural laborers; (2) employers of 6 or fewer agricultural or aquacultural laborers; and (3) employers of more than 6 such laborers when the total number of hours worked by all such laborers in a week does not exceed 240 (which is the equivalent of 6 full-time laborers) and has not exceeded 240 at any time during the 52 weeks immediately preceding the injury.</p>	<p>http://www.maine.gov/wcb/</p>	<p>http://www.maine.gov/wcb/departments/board.htm</p>

Minnesota	Required (limited)	Employers that are "family farms" do not have to provide workers' compensation.
