Organizing for Outreach (2020-2023)

Farmworker Justice worked with four community partners in states with federally facilitated marketplaces to provide farmworker families information and support enrollment in health insurance options through the Affordable Care Act (ACA) marketplace and Medicaid.

Community partners:

- Family Health La Clinica (FHLC)
- Moses Lake Community Health Center (MLCHC)
- North Carolina Farmworker Health Program (NCFHP)
- Farmworker Association of Florida (FWAF)
- East Coast Migrant Head Start Program (ECMHSP)

Organizing for Outreach: Activities

- Developed a series of fact sheets on the Affordable Care Act, health insurance, and eligibility guidelines for the ACA marketplace for farmworker families. Fact sheets are currently available in English, Spanish, Haitian Creole, Mam, and Mixteco.
- Developed an outreach guide to the ACA as a companion to the ACA fact sheets to help community outreach workers. Available in English and Spanish.
- Created film resource, <u>El Triunfo del Amor...y la Salud</u>, to educate farmworkers about their health insurance options.
- Over 2,000 people have been enrolled in the ACA and Medicaid through direct assistance or referrals by our community partners.

Affordable Care Act Marketplace Insurance for H-2A Workers

What is health insurance?

Health insurance helps you pay the cost of medical care while you are living and working in the United States.

Health insurance helps pay for medical care not covered by workers' compensation. With health insurance, you pay a certain small, fixed amount each month.
